Hays County Emergency Services District #4 will hold a Regular Meeting on **Tuesday, December 17, 2024, at 5:00pm,** at 111 Green Acres Drive in Wimberley, Texas for the following purposes:

- 1. Call meeting to order and verify quorum;
- 2. Public Comment: In accordance with the Texas Attorney General's opinion, any public comment that is made regarding an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners. Individual members of the public may address the Board for a maximum of three minutes regarding items not on the current agenda, for a collective total of fifteen minutes.

Members of the public will speak on agenda items after comments are called for by the presiding officer, but before Board discussion and consideration of the item. Individual members of the public may address the Board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;

- 3. Approval of minutes from the regular meeting held on November 26, 2024;
- 4. Receive monthly report from the Treasurer and consider:
 - a) Approval of payment of monthly invoices including payroll; and
 - b) Approval of monthly financial reports prepared by bookkeeper;
- 5. Receive monthly report from Assistant Chief Robbins regarding emergency operations, personnel and management activities, training, and community outreach;
- 6. Receive monthly report from Chief Czichos regarding stations, apparatus, and equipment;
- 7. Discuss and consider action on monthly report from District's Attorney regarding pending litigation matters, contract issues, tax and budgeting issues, and legislative efforts;
- 8. Discuss and consider action on responses to Request for Qualifications for future Station 42;
- 9. Discuss and consider action on Request for Qualifications for Owner's Representative;
- 10. Discuss and consider action on repairing the well house on the District's property in Burnet Ranches;
- 11. Discuss and consider action on Hays County Combined Communication Center;
- 12. Discuss and consider action on Jotform Enterprise;
- 13. Discuss date, time, location, and agenda items for next meeting;
- 14. Adjourn.
