1. Call meeting to order and verify quorum;

Mr. Joe Pendleton called the meeting to order at 5:01pm. Commissioners present: Mr. Joe Pendleton, Mr. Travis Brown, and Mr. Joseph Malone. Our goal is to have all of our full-time staff Certified as Hazmat Material Technicians.
- 6. Receive report from Chief Czichos regarding stations, apparatus, and equipment;
 Chief Czichos reported Engine 41 incurred some minor damage on a call. Czichos is working with
 Metro Fire to repair. Engine 42 will have a tire replaced due to running over a piece of steel in the
 road.

Mr. Brown made a motion to amend the previous motion to allow Jacob Wiley to use his discretion when determining the appropriate dept of the well. Seconded by Mr. Malone. All in favor.
